Commitment	Prevention of Modern Slavery

	Due Diligence

We will conduct thorough due diligence on our suppliers and business partners to assess and mitigate the risk of modern slavery within our supply chain. This includes a review of their policies, practices, and commitment to human rights.

• Transparency

We will maintain transparency in our operations and supply chain, making efforts to communicate our commitment to preventing modern slavery to all stakeholders. This includes sharing our policies and practices, as well as encouraging our business partners to do the same.



• Training and Awareness

	We will provide training and awareness programs to our employees and relevant stakeholders to ensure they understand the signs of modern slavery and their role in its prevention.
Reporting and Whistleblowing	We encourage all employees, contractors, suppliers, and business partners to report any concerns related to modern slavery to the appropriate channels within CMS. We will ensure that whistleblowers are protected and that their concerns are investigated thoroughly and confidentially.
Compliance and Consequences	Failure to comply with this Modern Slavery Policy may result in disciplinary action, termination of contracts, or legal consequences, depending on the severity and nature of the violation.
Continuous Improvement	We are committed to continuously improving our efforts to prevent modern slavery. This includes regular reviews of this policy, conducting risk assessments, and collaborating with relevant stakeholders to share best practices.
Communication	This Modern Slavery Policy will be made accessible to all employees, contractors, suppliers, and business partners.
Review and Approval	This Modern Slavery Policy will be reviewed and approved as per our QA procedures to ensure its effectiveness and relevance.
